RATES OF USE

ACTIVATOR 90 is authorised for use up to a maximum concentration of 0.1% dilution of the final water volume e.g.:-

Water Volume	Required Quantity of ACTIVATOR 90 at 0.1%
200 litres/ha	200 ml
400 litres/ha	400 ml

MIXING

Half fill the spray tank with water and commence agitation. Add the required quantity of **ACTIVATOR 90** then add the recommended quantity of pesticide. Continue agitation while topping up the tank and during spraying.

DIRECTIONS FOR USE

ACTIVATOR 90 can be used with all approved pesticides which have a recommendation for use with a non-ionic wetter.

Not all Horticultural / Amenity crops and or situations have been evaluated. Therefore you are advised to try the product first on a small scale before widespread use. This is especially important with those crops known to be sensitive or where even minor speckling of the leaves would reduce their value e.g. flower crops. De Sangosse Ltd. is unable to accept liability for any damage resulting from failure to follow these guidelines.

ACTIVATOR 90 may be used at a maximum concentration of 0.1% of spray solution on certain crops, up to specific growth stages, with all approved pesticides, applied up to their full approved rate.

ACTIVATOR 90 is authorised for use with all approved pesticides on all edible crops provided that the statutory conditions of use for the pesticide are followed and that the pesticide is not used at more than 50% of the maximum approved rate for that application.

ACTIVATOR 90 is authorised for use with all approved pesticides on all non-edible crops provided that the statutory conditions of use for the pesticide are followed.

ACTIVATOR 90 may be used to reduce drift of sprays where this is a concern.
