DIRECTIONS FOR USE

NEWMAN CROSPRAY 11-E may be used at a maximum concentration of 2.5% of spray solution on certain crops, up to specific growth stages, with all approved pesticides applied up to their full approved rate.

For Specific Recommendations contact De Sangosse Ltd or its appointed Distributors.

NEWMAN CROSPRAY 11-E is authorised for use with all approved pesticides on all edible crops provided that the statutory conditions of use for the pesticide are followed and that the pesticide is not used at more than 50% of the maximum approved rate for that application.

NEWMAN CROSPRAY 11-E may be used to reduce the drift of sprays where this is a concern.

NEWMAN CROSPRAY 11-E is authorised for use with the listed approved herbicides on cereals as detailed in the following table:-

Crop/Situation	Pesticide	Maximum Concentration (% of spray solution)
Cereals	All authorised salt formulations of MCPA or 2,4-D	1.25

MIXING

Three quarter fill the spray tank with water and commence agitation. Add the required quantity of **NEWMAN CROSPRAY 11-E**. Add pesticide(s) as directed. Continue agitation while topping up the tank and during spraying.

DO NOT apply **NEWMAN CROSPRAY 11-E** in tank-mixtures with herbicides under conditions conducive to moderate to severe frost. If a severe and/or prolonged frost follows application, the crop will suffer yellowing of the leaves and may be checked, however the effects are usually transient and crops normally recover.

DO NOT leave the **NEWMAN CROSPRAY 11-E** and pesticide solution in the spray tank without agitation, or separation may occur which may result in poor control.

DO NOT use **NEWMAN CROSPRAY 11-E** in tank-mixtures with any sulphur based pesticide or nutrient.

Ensure that all spraying equipment is thoroughly washed out with De Sangosse Tank and Equipment Cleaner or Spray-Safe immediately after use.
